

Flaccid inner diameter measurement of grafts in study




Pressurized outer diameter measurement of grafts in study





Code	Description	Sizing (Length)
Al	Aortoiliac	Suprarenal to a minimum of 4 cm distal to the iliac bifurcation
DAI	Distal Aorta & Iliacs	Infrarenal to a minimum of 4 cm distal to iliac bifurcation
ABA	Abdominal Aorta	Infrarenal to I cm distal to the iliac bifurcation

Fragile. Store at liquid nitrogen vapor phase temperature (-120°C or below) and carefully follow the thaw and dilution instructions.
